**DECLARATION OF DANIEL S. MASON
IN SUPPORT OF PLAINTIFFS' MOTION
FOR REASONABLE ATTORNEYS' FEES
AND COSTS**

1 I, DANIEL S. MASON, declare:

2 1. I am an attorney at law and a member of the California and District of Columbia
3 bars.

4 2. I make this Declaration in support of Plaintiffs' Motion for Reasonable Attorneys'
5 Fees and Costs in the above-captioned action. The facts stated herein are true as of my own
6 knowledge. If called to testify, I could and would competently testify thereto.

7 3. I am generally familiar with this litigation. I am familiar with the Court's denial
8 of Uber's Motions to Dismiss and for a More Definite Statement, which argued that Uber is not a
9 "public accommodation" under the ADA and that certain Plaintiffs lacked standing to sue. I am
10 also generally familiar with the comprehensive settlement Plaintiffs achieved. The settlement in
11 this case provides for substantial improvements to Uber's policies and procedures, including the
12 creation of a clear and comprehensive service animal policy, dissemination of information about
13 drivers' obligation to serve riders with service animals, removal of drivers who discriminate,
14 improved customer service for persons with service animals, and robust tracking, monitoring,
15 and testing of compliance with the service animal policy. These important improvements will
16 impact thousands of Americans with vision disabilities who travel with service animals. I
17 understand that this settlement was reached after litigation and extensive negotiations.

18 **GENERAL BACKGROUND AND EXPERIENCE**

19 4. I am a 1972 graduate of Duke University School of Law and have been a
20 practicing lawyer for over forty years. I served as a law clerk to Judge O.D. Hamlin, United
21 States Court of Appeals for the Ninth Circuit from 1972-1973. From 1973 to May 2000, I was
22 an associate, partner, and managing partner of Furth, Fahrner & Mason, and its predecessors.
23 Thereafter, Furth, Fahrner & Mason merged with Zelle LLP, where I am currently a senior
24 partner until September 1, 2016.

25 5. Attached hereto as Exhibit A is a true and correct copy of my current resume.

26 6. My practice focuses on antitrust and business litigation. I have extensive
27 experience in complex litigation matters in the areas of antitrust, trade regulation, international

1 trade law, unfair competition, and intellectual property. I have served as an appointed mediator
2 and participated in numerous arbitrations and mediations.

3 7. Zelle handles antitrust/competition and other complex business litigation
4 throughout the United States and internationally. Zelle has offices in Boston, Dallas, Miami,
5 Minneapolis, New York, Philadelphia, San Francisco, Washington, D.C., London, and an
6 affiliated office in Beijing. My practice is based out of the San Francisco office.

7 **BILLING RATES FOR ATTORNEYS PRACTICING COMPLEX LITIGATION**

8 8. I am familiar with hourly rates charged by attorneys handling complex cases such
9 as this one in the Bay Area. My own hourly rate charged to business clients in 2016 is \$895 per
10 hour. Based on my familiarity with rates generally charged in the Bay Area and nationwide, I
11 believe that my hourly rate is comparable to the currently prevailing rates charged by attorneys
12 in the Bay Area, of comparable skill, qualifications, experience, and reputation in matters having
13 a degree of complexity similar to the matters that I handle.

14 9. I have been engaged in several matters as co-counsel with attorneys at Disability
15 Rights Advocates (“DRA”). Their qualifications, reputation, and experience are equal to, if not
16 greater than, many elite members of the California bar. Their skills are demonstrated by the
17 great success they have enjoyed in litigating complex disability cases for many years.

18 10. I am also familiar with the work of the attorneys at Rosen Bien Galvan &
19 Grunfeld (“Rosen Bien”). Rosen Bien attorneys are skilled and experienced attorneys with a long
20 history of significant successes in complex litigation, including litigation under disability rights
21 laws. Their qualifications, reputation, and experience are equal to, if not greater than, many elite
22 members of the California bar.

23 11. I am also familiar with the work of Timothy Elder of TRE Legal. Mr. Elder has
24 spent his career litigating disability rights cases, and has qualifications, reputation, and
25 experience comparable to many elite members of the California bar.

PLAINTIFFS' COUNSEL'S BILLING RATES ARE REASONABLE

12. I have reviewed the 2016 billing rates claimed by Plaintiffs' counsel in this case, DRA, Rosen Bien, and Mr. Elder. DRA's attorney rates range from \$355 to \$895 for attorneys who graduated from law school between 1985 and 2014. Rosen Bien's attorney rates range from \$460 to \$900 for attorneys who graduated from law school between 1980 and 2011. Mr. Elder's rate is \$475 and he graduated from law school in 2010. These rates are reasonable and within the range of 2016 hourly rates for attorneys practicing complex litigation in the Bay Area. These rates are comparable to the rates of attorneys of comparable skill, qualifications, reputation, and experience in the Bay Area legal market. DRA and Rosen Bien also seek hourly rates for their paralegals and summer associates ranging from \$275 to \$280. These rates are also reasonable and within the range charged to fee-paying clients by Bay Area law firms handling complex litigation in 2016.

If called as a witness, I could and would competently testify from my personal knowledge to the facts stated herein.

I declare under penalty of perjury that the foregoing is true and correct, and that this declaration was executed on Sept 13, 2016, in San Francisco, California.

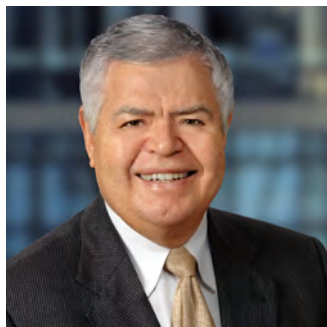
